5. It may be mentioned that limited hostel facilities are available for the participants, who wish to stay in campus. For the participants opting for hostel facilities, the hostel and mess charges (all inclusive) shall be approximately Rs. 400/- per day. This includes Rs. 100/- room rent, Rs. 100/- Breakfast + bed tea, Rs. 200/- for dinner. Moreover, Rs. 250/- per day for lunch and tea/snacks (twice a day) is to be paid separately at the time of registration by all the participants. 
