Subject: Training of Authorised Officers for clearance of food-related consignments at locations where FSSAI has provided delegation to Customs officers-reg.

The Food Safety & Standards Authority of India (FSSAI) has notified the Customs officials to perform the functions of an 'Authorised Officer' and handle food import clearance in terms of the provisions of the Food Safety and Standards Act, 2006.

2. In view of the above, the FSSAI has proposed to train the "Authorised Customs Officers" to make them familiar with procedural and legal requirements relating to food safety, for the clearance of food-related import consignments. The FSSAI would provide source trainers for conducting the proposed training. The schedule of the training is enclosed for information. Accordingly, NACIN, ZTI, New Delhi is organizing a one-day training course of Authorized Customs officers on food related regulations and procedures on 19th November, 2018 at NACIN, Zonal Training Institute, 3rd Floor, Tower 3 & 4, NBCC Plaza, Saket, New Delhi -110 017.

3. It is requested that the 'authorized officers' (Appraiser/ Superintendent/ Inspector/ Examiner) for clearance of food related consignments of various of ICDs, LCS and CFS under your zone/charge may be nominated for participating in the above course. The details of the officers may be sent in the format enclosed as Annexure-A.

4. It may be noted that the Zonal training institute, NACIN does not provide hostel and canteen facility. However, the food can be arranged on payment basis.
