**Subject:-Weekly Report in respect of important developments in CBEC for the week
-23.10.15 to 27.10.15 reg.**

Based on the inputs received from various sections, following is the compilation of the important developments for the week – **23.10.15 to 27.10.15**.

1. Administrative Changes:-

- Order regarding Placement of Services of Shri Dinesh K. Chakravarty, IRS with Serious Fraud Investigation Office(SFIO) has been issued vide Office Order No. 153/2015 dated 29.10.2015.
- Order regarding assigning of additional charge of the post of Commissioner Appeals-III, Cochin (Appeal of Trivandrum Commissionerate) to Shri Mathew Jolly, Commissioner(Audit), Cochin has been issued vide Office Order No. 154/2015 dated 29.10.2015.
- Order regarding assigning of additional charge of the post of Commissioner of Siliguri Commissionerate to Ms. Bandana Deori, Commissioner of Customs(P), Shillong has been issued vide Office Order No. 155/2015 dated 29.10.2015.
- Order regarding placement of services of three IRS officers on their appointment as US/TO with CBEC under Revenue Headquarters has been issued vide Office Order No. 156/2015 dated 30.10.2015.

2. Legislative Changes:-

- Notification No. 52/2015-Cus(ADD), dated 28.10.2015 has been issued to extend the validity of notification No 108/2010-Customs, dated the 6th October, 2010 imposing Anti-Dumping Duty on narrow woven falnic [CTH 5806] originating in or exported from China or Chinese Taipei for a further period of one year.
- Notification No. 53/2015-Cus(ADD), dated 30.10.2015 has been issued to order provisional assessment on imports of Clear Float Glass of nominal thickness ranging from 4 mm to 12 mm (both inclusive), the nominal thickness being as per BIS 14900:2000, falling under the headings 7003, 7004, 7005, 7009, 7013, 7015, 7016, 7018, 7019, 7020 of the First Schedule to the Customs Tariff Act, originating in or exported from Pakistan, Saudi Arabia and UAE by M/s Tariq Glass Industries Limited, Pakistan (exporter) till the finalization of New Shipper Review initiated by DGAD, initiated vide notification No. 15/16/2015-DGAD, dated 23rd September, 2015.
- Notification No. 22/2015-CENT, dated 29.10.2015 has been issued to further amend Cenvat Credit Rules, 2004, so as to allow credit of Education Cess and Secondary and Higher Education Cess paid on inputs/input services and capital goods, to be utilized for payment of service tax in specified circumstances.
