**Subject:-Weekly Report in respect of important developments in CBEC for the week –01.05.17 to 05.05.17 reg.**

Based on the inputs received from various sections, following is the compilation of the important developments for the week –01.05.17 to 05.05.17.

**1. Administrative Changes:-**

- Order regarding assigning of additional charge of the Central Excise Salem Commissionerate, Central Excise Tirunelveli Commissionerate and Coimbatore(Audit) Commissionerate to Shri S. Thirunavakkarasu, Commissioner of Central Excise LTU, Chennai has been issued vide Office Order No. 62/2017 dated 01.05.2017.
- Order regarding allocation of work among Members of CBEC has been issued vide Office Order No. 63/2017 dated 03.05.2017.
- Order regarding assigning of additional charge of the post of Director General of Systems and Data Management to Shri Vivek Johri, Principal Commissioner of Customs ACC(Import) Delhi (Holding additional charge of Chief Commissioner, Delhi Customs Zone) has been issued vide Office Order No. 64/2017 dated 04.05.2017.

**2. Legislative Changes:-**

- Notification No. 14/2017-Cus(ADD) dated 03.05.2017 has been issued to extend the levy of anti-dumping duty, imposed on Viscose Filament Yarn originating in or exported from China PR under notification No. 23/2012-Customs (ADD), dated 04.05.2012, for a further period of one year i.e. upto and inclusive of 03.05.2018.
- Notification No. 15/2017-Cus(ADD) dated 03.05.2017 has been issued to levy definitive anti-dumping duty on import of Elastomeric Filament Yarn from China PR, South Korea, Taiwan and Vietnam for a period of five years (unless revoked, superseded or amended earlier) in pursuance of final findings of the Directorate General of Anti-Dumping & Allied Duties dated 24.03.2017.
- Notification No. 7/2017-Service Tax dated 04.05.2017 has been issued to amend Notification No. 25/2012-ST dated 20.06.2012 so as to exempt life insurance services under 'Pradhan Mantri Vaya Vandana Yojana'.
