**Subject:-Weekly Report in respect of important developments in CBEC for the week –  
07.09.15 to 11.09.15 reg.**

Based on the inputs received from various sections, following is the compilation of the important developments for the week – **07.09.15 to 11.09.15**.

**1. Administrative Changes:-**

- Order regarding assigning of additional charge of five posts of Commissioner(Appeals), Central Excise, Customs and Service Tax has been issued vide Office Order No. 131/2015 dated 09.09.2015.
- Order regarding assigning of additional charge of the post of Commissioner, Central Excise, Ludhiana to Commissioner, Customs, Ludhiana has been issued vide Office Order No. 132/2015 dated 09.09.2015.
- Order regarding appointment of Shri A.K. Sapra, Assistant Commissioner as OSD in Customs Wing of CBEC has been issued vide Office Order No. 133/2015 dated 09.09.2015.
- Order regarding promotion of 37 Assistant Commissioner to the grade of Deputy Commissioner of Customs and Central Excise on ad-hoc basis notionally w.e.f. 18.07.2014 i.e. the date from which their juniors were promoted to the said grade has been issued vide Office Order No. 134/2015 dated 11.09.2015.

**2. Legislative Changes:-**

- Notification No. 47/2015-Cus(ADD), dated 08.09.2015 has been issued to levy definitive anti-dumping duty on imports of Float Glass of thickness 2 mm to 12 mm (both inclusive) of clear as well as tinted variety (other than green glass) but not including reflective glass, processed glass meant for decorative, industrial or automotive purposes falling under chapter heading 7005 of the First Schedule to the Customs Tariff Act, originating in or exported from the Peoples' Republic of China for a period of five years.
