

I am enclosing herewith copy of the reference received from Ministry of Drinking Water & Sanitation [MDWS] informing about organizing of 'Swachhata Pakhwada' in this Department from 16th to 31st January, 2019 under SAP 2018-19 and prior briefing meeting to be held by Secretary, MDWS in this regard with all the nodal officers on 26th December, 2018 at 4.00 P.M.

I would like to inform that this year MDWS will be providing three awards to each Ministry/Department for contributing maximum to the cause of sanitation, specifically on the basis of innovative activities and initiatives, mass mobilization for Swachhata, engagement of varied sections outside the organization, etc., which have deep and sustainable impact countrywide. The selection process for first/second/third prize winners would be overseen by Secretary of the Department, which then would be conveyed to the Ministry of Drinking Water and Sanitation within two days after completion of the 'Swachhata Pakhwada'. A copy of the d.o. letter dated 13.3.2018 from Secretary, MDWS alongwith consolidated guidelines is enclosed for reference please.

I shall be grateful if you could kindly direct the concerned nodal officers to attend the briefing meeting being held on 26.12.2018 as intimated by MDWS and initiate urgent action with regard to organizing of 'Swachhata Pakhwada' as per schedule in all the field offices under your control. They may also be directed to take up other conceivable activities in addition to the proposed Action Plan as per consolidated guidelines issued by MDWS in this regard.
